SSCB Serious Case Reviews



The SSCB is currently undertaking three Serious Case Reviews, three partnership reviews and one multi-agency audit. As each review is completed, the reports and learning will be summarised [here](#).

We would like to draw the attention of professionals to the learning of the SCR Child GG, in relation to a young person who was the victim of sexual exploitation, which was published recently. The review highlighted, among others, the importance of professionals' understanding the impact of conditions such as ADHD, ASD etc. on children's behaviour. This includes impulsivity and difficulties in understanding the impact of their behaviour and the consequences of their actions. It is therefore essential to secure expertise to support the understanding of professionals and to support best management of challenging behaviour. Escalation Policy



If professionals within the Surrey Partnership have concerns that they feel are not being addressed for example the interpretation of Thresholds or Practice of a partner organisation please refer to the [SSCB Inter-agency escalation policy and procedure](#). This procedure includes a flow chart to support professionals in raising a concern and should be followed as described, concerns should only be escalated to the SSCB once all the previous stages have been exhausted. The Escalation Policy enables partners to work together to address the concern at the earliest possible opportunity. Serious Case Review learning indicates that not all professionals use the procedure appropriately. We are happy to support professionals if they need advice of the appropriate next step to take. Surrey Police: Partnership Intelligence

Surrey Police is relaunching and increasing awareness of the Partnership Intelligence [Form](#); a means for partners to quickly and efficiently share intelligence.

New step by step [guidance](#) has been drafted and there is a new simplified version of the form. Simply follow the guidance and submit to: partnership.intelligence@surrey.pnn.police.uk



This is not a means to: report a crime, notify police of an imminent risk, refer a child or adult and does not replace existing information sharing processes.

There are numerous other ways to share intelligence with us including; 999 (if an emergency), 101, telling an officer or member of staff, online reporting, CrimeStoppers to name a few. However; this pathway to fast and efficient intelligence sharing with the police, for the purpose of protecting the public or prevention & detection of crime, is now also available to you as a partner agency. (All explained within the guidance.

Signs of Safety

In 2016 we developed our 'Safer Surrey' practice which has been an important stepping stone in helping us clarify our overall ambition, our absolute priority and our approach to working with children and families. More recently we adopted Signs of Safety as our practice model for social work and have been training managers and practitioners to use this. Both approaches are strengths-based and child focused, with some similarities but also some key differences. However feedback showed that there's considerable confusion about the relationship between Safer Surrey and Signs of Safety, not least because of some very similar words!



The work on Safer Surrey has helped us develop our practice and make improvements. Listening to feedback, and after conversations and reflections with practice leads across our services, we know that the term is no longer helpful in describing our practice and the ways we are developing practice across Children, Schools and Families (CSF) and with partners.

So, we've agreed we'll stop using the term 'Safer Surrey' as it has completed its job in setting us on a road towards a whole system approach to improving outcomes for children and families. We're only dropping the label - because we will absolutely continue the important work to develop our strength-based and child and family focused practice across CSF and with partners.



Signs of Safety - Strengths-based practice

Signs of Safety is our practice model for social work and therefore the primary approach used in Children's Services and areas of Surrey Family Services. We have a range of other approaches being used effectively in our work with children and families in social care and right across our services, for example restorative practice, social pedagogy, systemic and person-centred approaches.

Partner training and information

SSCB Section 11 Audit

S11 Survey for non-statutory organisations



The Surrey Safeguarding Children Board (SSCB) assesses the effectiveness of local safeguarding arrangements in various ways, including Section 11 assessments. The Section 11 assessment is carried out in a two-year cycle. Year 1 includes statutory organisations and Year 2 includes non-statutory organisations. The 2017 programme included non-statutory organisations covering private, voluntary, community, sports, early years and faith-based sector organisations who provide services to children in Surrey. A self-assessment tool (via an online survey) was sent to a wide range of organisations for completion. 88 organisations across the whole of Surrey completed the on-line survey. A report has been produced to present the findings from the survey results.

Organisations that completed the survey highlighted that they would like to receive the following support/information from statutory organisations:

- Updated information on safeguarding policies, procedures and training
- Accessibility and availability of training courses

- More on-line safeguarding courses
- More information/update and training on online safety, CSE, trafficking, radicalisation
- Timely updates and feedback on referrals made
- Sharing learning from Case studies involving those in a position of trust from a faith context

The Children and Young People's (CYP) Haven

The Children and Young People's (CYP) Haven is a friendly, safe space that children and young people aged 10-18 can go to for emotional support instead of needing to attend Accident and Emergency. It doesn't have a clinical feel and is run as a service rather than a youth club. It provides young people with the support of a youth worker, a youth mental health nurse and a peer support worker.



It also helps them to address any social issues, such as potential homelessness and abuse, as well as supporting them through the mental health system which can be confusing. It is a drop-in service that young people can be directed to without needing a referral. You can simply turn up during their opening times. Click [here](#) for venues and opening times.

Catch22 Surrey Young people’s Substance Misuse Service (SYPSMS)

Catch22 Surrey Young people’s Substance Misuse Service (SYPSMS) is a county-wide specialist treatment service, offering; one-to-one support to young people and their families, a 24 hour help line, counselling and pharmacological support, as part of a tailored recovery approach for young people aged 11 to 21-years-old successfully delivering positive outcome for the young people we work with.

Young people are at the centre of all we do. We ensure the young person knows they will be listened to at all times. We work with young people at their pace, in an environment where they are comfortable – we don’t expect them to travel to us. We also offer volunteering opportunities.

How we help

- A ‘harm-reduction’ approach
- A 24/7 helpline line for young people and their families
- Rapid response for prescribing needs, including access to needle exchange
- Individually tailored help
- Family work
- Specialist support for mental health problems
- Transitional support to adult services



We also provide; targeted support, training, consultation advice and guidance to professionals, as well as additional support in Surrey through our Music to My Ears Emotional Health and Wellbeing Project and partnership work with CAMHS Mindful service.

Catch22 have a history of close positive partnership working with Surrey young people and families Services, education, housing, A&E’s, treatment providers, police and other agencies across Surrey ensuring young people get the right support they need, when they need it.

Healthy Surrey- MARAC

Operation Encompass

Early years education providers in the county such as nurseries, preschools and children centres, have been invited to join and participate in the national police project Operation Encompass.



Operation Encompass has been designed to provide early reporting on any domestic incidents that occur outside of 'normal' school hours, excluding school holidays. The settings/children centres Designated Safeguarding Lead (DSL) is informed as soon as possible the next working day morning that there has been a domestic incident or if a child has been reported as missing. We are keen to ensure that we offer the best support possible to the child/ren and we believe this is an extremely beneficial for all those involved. The DSL can then ensure that the child/ren are supported in the most appropriate way.

The early education safeguarding team and ESDAS (East Surrey Domestic Abuse Service) have run information workshops to explain how to project works and also the impact of DA on children.

The information sharing focuses on three specific categories of child:

- Those with a child protection plan
- Those with looked after child status
- Pregnant women whose unborn child has a pre-birth child protection plan

Lullaby Trust Safer Sleep Week March 2018



[Safer Sleep Week](#) is the Lullaby Trusts national awareness campaign targeting anyone looking after a young baby. It aims to raise awareness of sudden infant death syndrome (SIDS) and the proven advice on how parents can reduce the risk of it occurring.

Sadly around 4 babies a week still die from SIDS and if all parents were aware of safer sleep advice many lives could be saved.

The focus of Safer Sleep Week 2018 was on how parents can make safer choices when buying baby sleep products. The charity developed a [product guide](#), which is supported by Public Health England, and a [video](#) to help support parent's decision making when buying sleep items for their babies and raising awareness of what the essential items are for safer sleep.
